THE LAUNCHING PAD product preview area at the San Francisco International Gift Fair is open to all companies participating in the show. A **LIMITED NUMBER** of **assigned spaces** will be available on a first-come, first-serve basis.

SPACE SIZE: The dimensions for the Launching Pad platforms are 24" deep x 30" wide. No advertising flyers or documents are to be used in the display area. **Only product is to be displayed.** Show management retains the right to adjust or remove any display abusing space privileges.

COST: Top Shelf—\$75; Second & Third Row—\$55; Bottom Shelf—\$35.

REP GROUPS: If you are a rep group, you can reserve a space for your company highlighting your lines or your lines can purchase individual spaces.

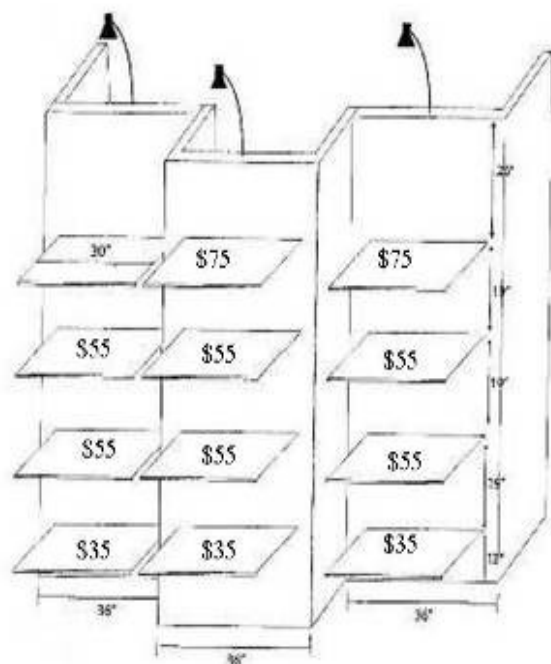
SET UP TIME: All displays are to be set by the participating company during move in and no later than **4:00 pm on Friday, February 17, 2012.**

ID SIGNS: Show management will place your **tent card** with your **company name and lowest booth number** in your assigned space.

NO EARLY BREAKDOWN OR PRODUCT PICK UP: Each exhibitor will be responsible for picking up their products at the close of the show. **You can pick up your products no earlier than 2:00 pm on Tuesday, February 21, 2012.**

GOOD NEIGHBOR POLICY: All exhibitors should abide by the "Good Neighbor Policy". If it is not your product, please do not touch it. No photography, handling or re-arranging. Violators will not be allowed in the display area.
